

General instructions to the Principals of TEIs for admission:

- i) Please complete the admission process for round wise allotment of institute as per the **schedule** enclosed herewith.
- ii) Please follow the steps for admission process as per the user manual enclosed herewith.
- iii) To login to the **web portal (<https://scertpet.co.in>)** for the admission process, login credentials can be obtained by using the Mobile No. of the Principals of the respective TEIs.
- iv) Please Verify/compare the information furnished by the respective candidates in the online application form by examining the following relevant documents in original before admission & in the event of any information being found false or incorrect or not satisfying any of the stipulated eligibility criteria, the admission of the candidates will be rejected by the Principal. Non following the guidelines, irregular admission, the Principal will be held personally responsible.

- a) Provisional allotment letter.
- b) Admit card of Pre-Entry Test (PET)-2025.
- c) Percentage of marks from Marksheet of Higher Secondary (+2) or its equivalent examination.
- d) Pass Certificate of Higher Secondary (+2) or its equivalent examination from recognized Boards / Councils.
- e) Date of birth from HSLC Admit Card/Certificate.
- f) Caste Certificate (if any).
- g) Document to proof that he/she is permanent resident of Assam.
- h) For the candidates applied for PWD category:

Candidates selected for admission under PWD quota will have to produce identity card and identified certificate from the State Level Medical Board/District Level Medical Board for verification at the time of admission in concerned TEI.

The following categories of Person with Disability (PWD) will be considered for admission subject to maintenance of benchmark disability that means a person with not less than forty per cent:

- i. Visually Impaired (VI)
- ii. Hearing Impaired (HI)
- iii. Orthopedically Handicapped (OH)
- i) EWS certificate (if any)
- e) Other relevant information if any required to be verified.

- v) Candidates are to submit an undertaking to the principals of the concerned TEIs at the time of admission as follows:----

"I do hereby declared that I have not taken any admission in other regular courses except 2-year Diploma in Elementary Education (D.El.Ed.) Course for the session 2025-27. The authority may cancel my candidature immediately with disciplinary action if anyone produce evidence of my engagement in any other regular courses or department in the same academic year and in the event of any information/document being found false or not satisfying any of the stipulated eligibility criteria for the course."
